Fund update for the quarter ended 30 September 2025

This fund update was first made publicly available on 28 October 2025.

What is the purpose of this update?

This document tells you how the Kernel High Growth Fund has performed and what fees were charged. The document will help you to compare the fund with other funds. Kernel Wealth Limited prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

Description of this fund

The Kernel High Growth Fund is a diversified fund comprising of several of the Kernel Funds. It is made up of over 98% growth assets, such as shares and listed property. This globally diversified fund is designed to help investors build long-term wealth while lessening volatility through geographical and sector diversification. It is suitable for an investor with an investment time horizon of at least 5 years.

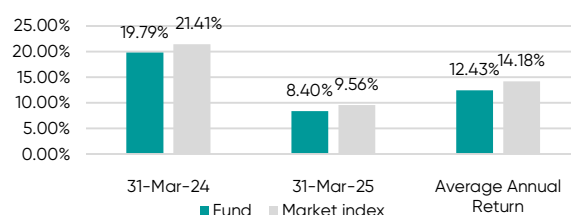
How has the fund performed?

Investors in the Kernel High Growth Fund are charged fund charges. In the year to 31 March 2025 these were:

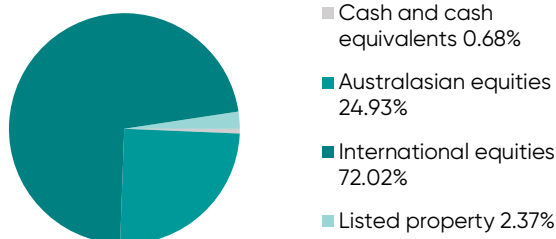

Currency Hedging:

The fund had a 16.54% allocation to the Kernel S&P Global 100 (NZD Hedged) Fund which was 99.01% hedged back to New Zealand dollars, a 12.50% allocation to the Kernel World ex-US (NZD Hedged) Fund which was 99.65% hedged back to New Zealand dollars, a 7.60% allocation to the Kernel Global Infrastructure (NZD Hedged) Fund which was 99.08% hedged back to New Zealand dollars, and a 2.38% allocation to the Kernel Global Property (NZD Hedged) Fund which was 98.91% hedged back to New Zealand dollars.

Notes

¹ Market index returns (as well as actual returns) have been used to complete the risk indicator, as the fund has not been in existence for 5 years. As a result, the risk indicator may provide a less reliable indicator of the potential future volatility of the fund. The risk indicator for the fund uses 1 year(s) 7 month(s) of market index returns.

Example of how this applies to an investor

Emma had \$10,000 in the fund on 1 October 2024 and did not make any further contributions. On 30 September 2025, Emma received a return after fund charges were deducted of \$1,781 (that is 17.81% of her initial \$10,000). This gives Emma a total return after tax of \$1,749 for the period.
