
Description of this fund

To provide high total returns allowing for large movements of value up and down. The number of years with negative returns are generally expected to be higher than the Balanced Fund but lower than the Aggressive Fund. We manage asset allocation and currency hedging over the medium to long term relative to the target investment mix. We focus on cost effective management. The Growth Fund invests in income and growth assets with a target investment mix of 22% income assets and 78% growth assets.

What are the risks of investing?

Risk indicator for Growth Fund




Example of how this applies to an investor

Jason had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Jason received a return after fund charges were deducted of \$630.00 (that is 6.30% of his initial \$10,000). Jason also paid \$0.00 in other charges. This gives Jason a total return after tax of \$630.00 for the year.

Currency hedging

As at 31 March 2025 the fund's exposure to assets denominated in foreign currencies was 72%, of which 54% was hedged. This means the fund's unhedged foreign currency exposure was 34% of the net asset value of the fund.
