Fund update for the quarter ended 31 March 2025

This fund update was first made publicly available on 1 May 2025.

What is the purpose of this update?

This document tells you how the Smart Automation and Robotics ETF has performed and what fees were charged. The document will help you to compare the fund with other funds. Smartshares Limited prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

Description of this fund

The Smart Automation and Robotics ETF is designed to track the return (before tax, fees and other expenses) of the iSTOXX® FactSet Automation & Robotics Index. The Index is comprised of stocks from developed and emerging market companies from sectors associated with the development of automatic and robotic technology.




How has the fund performed?

What fees are investors charged?

Investors in the Smart Automation and Robotics ETF are charged fund charges. In the year to 31 March 2025 these were:


Example of how this applies to an investor

Tara had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Tara incurred a loss after fund charges were deducted but before tax of -\$125 (that is -1.25% of Tara's initial \$10,000). This gives Tara a total loss after tax of -\$254 for the year.
