This fund update was first made publicly available on 13 February 2026.

What is the purpose of this update?

This document tells you how the Pathfinder KiwiSaver Growth Fund has performed and what fees were charged. The document will help you to compare the fund with other funds.

Pathfinder Asset Management Limited prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

Description of this Fund

The Fund is an ethical portfolio with a higher exposure to growth assets and a lower exposure to income assets. This Fund's value is likely to fluctuate more than the Pathfinder KiwiSaver Balanced Fund or Pathfinder KiwiSaver Conservative Fund.

What are the risks of investing?

Risk indicator for the Pathfinder KiwiSaver Growth Fund:





The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the fund’s assets goes up and down. A higher risk generally means higher potential returns over time, but more ups and downs along the way.



Annual Return Graph

What fees are investors charged?

Investors in the Pathfinder KiwiSaver Growth Fund are charged fund charges. In the year to 31 March 2025 these were:

** Other management and administration charges comprise fees paid by the Fund for its investment in the related funds, Pathfinder Green Bond Fund, and the Alvarium Sustainable Income Fund (replaced by the Pathfinder Wholesale Fixed Income Fund in July 2025).

*** Member fees are not applicable for members under 18 years old or members whose account balance is below \$1,000.

Performance fees and individual action fees: There are no performance fees or individual action fees.

Small differences in fees and charges can have a big impact on your investment over the long term.

Example of how this applies to an investor


Tara had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Tara received a return after fund charges were deducted of \$777 (that is 7.77% of her initial \$10,000). Tara also paid \$27 in other charges. This gives Tara a total return after fees, charges and tax of \$641 for the year.



What does the fund invest in?



The top 10 investments make up 19.37% of the net asset value of the fund.

Currency hedging: Changes in the value of the NZ dollar relative to other currencies can have a big impact on your investment over the long term. The target currency hedging is 50% of non-NZD equity exposure and 100% of non-NZD fixed interest exposure (actual hedging level at 31 December 2025 was 58.81% of the foreign currency exposure (this will change over time)). Total unhedged foreign exposure is 28.75% of the net asset value at 31 December 2025 (this will change over time).

Notes:

1. The market index changed on 1 December 2021. The previous index was a weighted composite benchmark index as described in the [SIPO](#) (“3. Investment objective and benchmark”) dated 3 April 2025. The new index is independently administered and widely used to compare funds in New Zealand. The manager also considers that the new market index is more appropriate for measuring changes in the market in relation to returns on the assets that the Fund invests in. As a result, the market index annual return is calculated using the previous market index for the period since Fund inception to 30 November 2021 and the new market index from 1 December 2021.
2. Actual Investment Mix - Other: Other assets are direct investments that are unlikely to be stock exchange listed. These can include investments known as ‘impact investments’, ‘venture capital’, ‘private loans’ and ‘private equity’. This category also includes unlisted property, such as direct ownership in property or ownership of property companies that are not listed on a stock exchange. Some of the private loans are with entities related to Pathfinder. Currently, the Fund’s exposure to these private loans is 0.13% of the net asset value.
