What is the purpose of this update?

This document tells you how the Australian Growth Fund has performed and what fees were charged. The document will help you to compare the fund with other funds. 
How has the fund performed?

Managed Funds

What fees are investors charged?

Investors in the Australian Growth Fund are charged fund charges that include GST. In the year to 31 March 2024 these were:


Katie had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Katie received a return after fund charges were deducted of \$1,143 (that is 11.43% of her initial \$10,000). Katie did not pay other charges. This gives Katie a total return after tax of \$1,143 for the year.



What does the fund invest in?


Actual investment mix

Currency hedging

The benchmark currency hedge ratio for Australian equities is 70% hedged into NZD. At quarter end the fund was 69.6% hedged into NZD.
