Fund update for the quarter ending 30 June 2025

This fund update was first made publicly available on 25 July 2025.

What is the purpose of this update?

This document tells you how the Sharesies Pathfinder Ethical Growth Fund has performed and what fees were charged. The document will help you to compare the fund with other funds. Sharesies Investment Management Limited prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

Description of this fund

The fund invests wholly in the Pathfinder Ethical Growth Fund, an ethical portfolio with a higher exposure to growth assets and a lower exposure to income assets.

What are the risks of investing?

Risk indicator for the Sharesies Pathfinder Ethical Growth Fund¹



The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the fund's assets goes up and down. A higher risk generally means higher potential returns over time, but more ups and downs along the way.

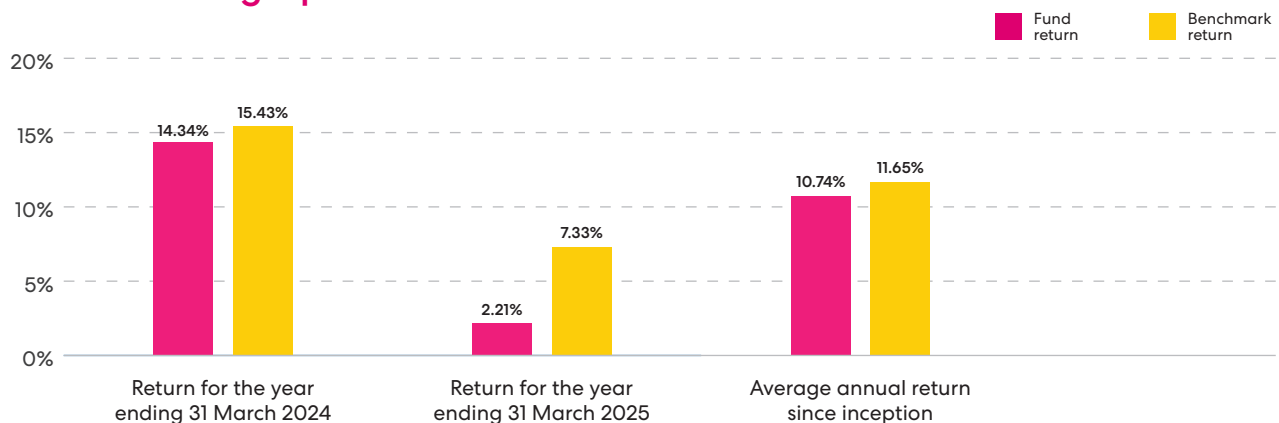


How has the fund performed?

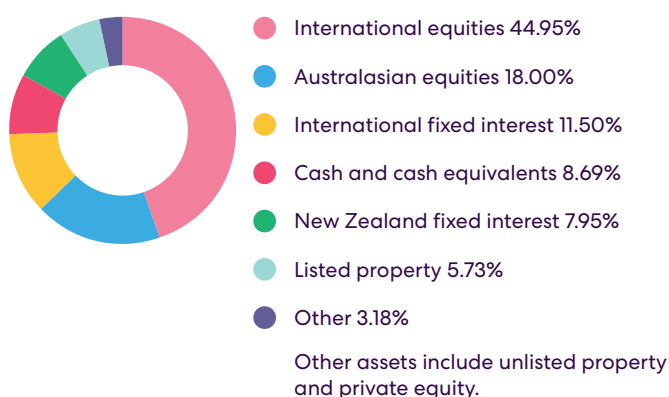
Example of how this applies to an investor

Katy had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Katy received a return after fund charges were deducted of \$662.51 (that is 6.63% of her initial \$10,000). Katy did not pay any other charges. This gives Katy a total return after tax of \$602.41 for the year.

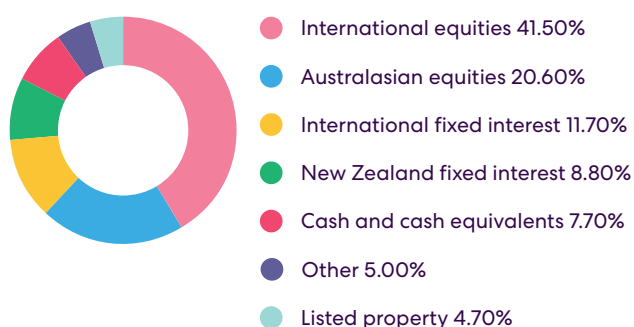

Notes
