

Smart Global Bond ETF

Fund update for the quarter ended 30 September 2024

This fund update was first made publicly available on 29 October 2024.

What is the purpose of this update?

This document tells you how the Smart Global Bond ETF has performed and what fees were charged. The document will help you to compare the fund with other funds. Smartshares Limited prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

Description of this fund

The Smart Global Bond ETF is designed to provide a return (before tax, fees and other expenses) that outperforms the Bloomberg Global Aggregate Total Return Index Hedged NZD by 1% per annum over rolling three-year periods. The investment manager is PIMCO Australia Pty Ltd.

The currency exposure is hedged to the New Zealand dollar.

What are the risks of investing?

Risk indicator for the Smart Global Bond ETF



The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the fund's assets goes up and down. A higher risk generally means higher potential returns over time, but more ups and downs along the way.

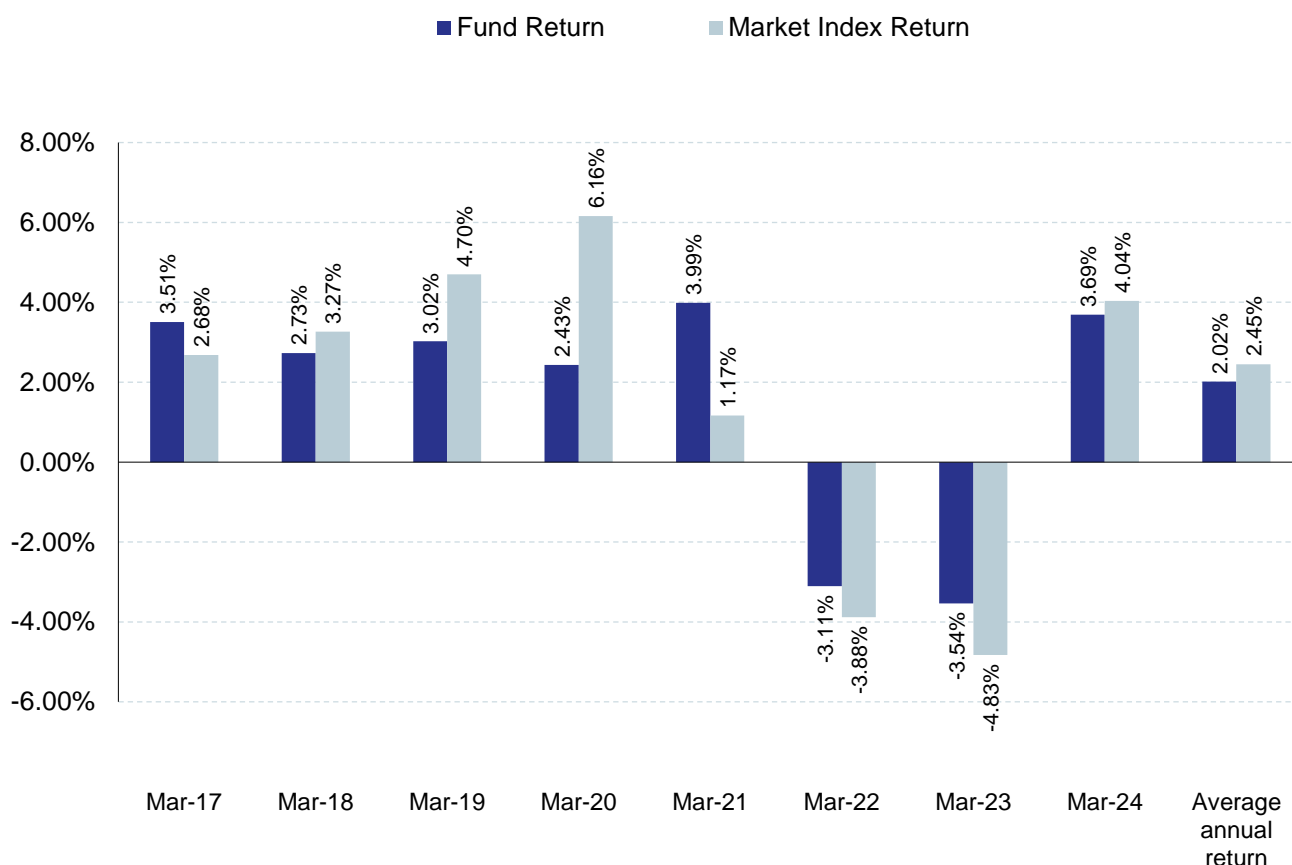

How has the fund performed?

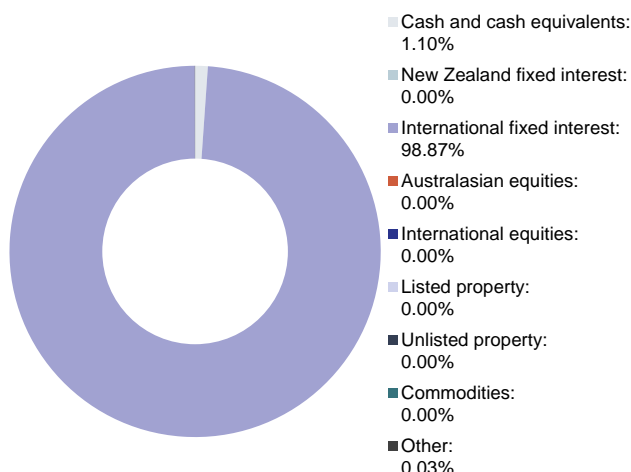
Example of how this applies to an investor

Tara had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Tara received a return after fund charges were deducted but before tax of \$1,079 (that is 10.79% of Tara's initial \$10,000). This gives Tara a total return after tax of \$769 for the year.

Currency hedging

As at 27 June 2024 the fund's exposure to assets denominated in foreign currencies was 100.52%, of which 100.12% was hedged. This means the fund's unhedged foreign currency exposure was 0.00% of the net asset value of the fund. Notes

- 1 These charges refer to the normal fund operating costs that are charged to the fund. For disclosure purposes, supervisor, audit and legal costs are not included in the manager's basic fee, but are included in the other management and administration charges. Some of these are fixed costs so the amount shown can range from 0% up to the total fund charges depending on the total value of the fund.
