### What is the purpose of this update?

This document tells you how the Income Fund has performed and what fees were charged. The document will help you to compare the fund with other funds. Fisher Funds Management Limited prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

### Description of this Fund

The fund aims to provide stable returns over the long term by investing in New Zealand and international fixed interest assets.

### What are the risks of investing?

Risk indicator for the Income Fund:



The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the fund's assets goes up and down. A higher risk generally means higher potential returns over time, but more ups and downs along the way.



### How has the fund performed?

## Annual return graph



This shows the return after fund charges and tax for each of the last 10 years ending 31 March. The last bar shows the average annual return for the last 10 years, up to 31 December 2025.

## What fees are investors charged?

Investors in the Income Fund are charged fund charges that include GST. In the year to 31 March 2025 these were:


### Example of how this applies to an investor

Katie had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Katie received a return after fund charges were deducted of \$347 (that is 3.47% of her initial \$10,000). Katie did not pay other charges. This gives Katie a total return after tax of \$347 for the year.

### Actual investment mix


This shows the types of assets that the fund invests in.

### Currency hedging

The benchmark currency hedge ratio for International fixed interest is 100% hedged into NZD. At quarter end the fund was 100.0% hedged into NZD.
