

## Smart NZ Top 50 ETF

### Fund update for the quarter ended 31 March 2025

This fund update was first made publicly available on 1 May 2025.

### What is the purpose of this update?

This document tells you how the Smart NZ Top 50 ETF has performed and what fees were charged. The document will help you to compare the fund with other funds. Smartshares Limited prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

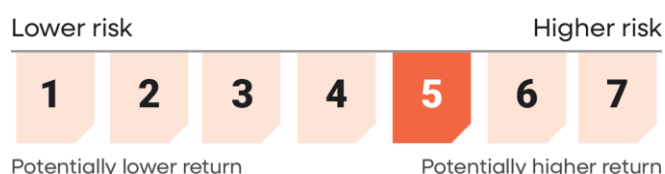
### Description of this fund

The Smart NZ Top 50 ETF is designed to track the return (before tax, fees and other expenses) of the S&P/NZX 50 Portfolio Index. The Index is comprised of 50 of the largest companies listed on the NZX, with a 5% cap on the weight of each company within the Index.

### What are the risks of investing?

#### Risk indicator for the Smart NZ Top 50 ETF



The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the fund's assets goes up and down. A higher risk generally means higher potential returns over time, but more ups and downs along the way.

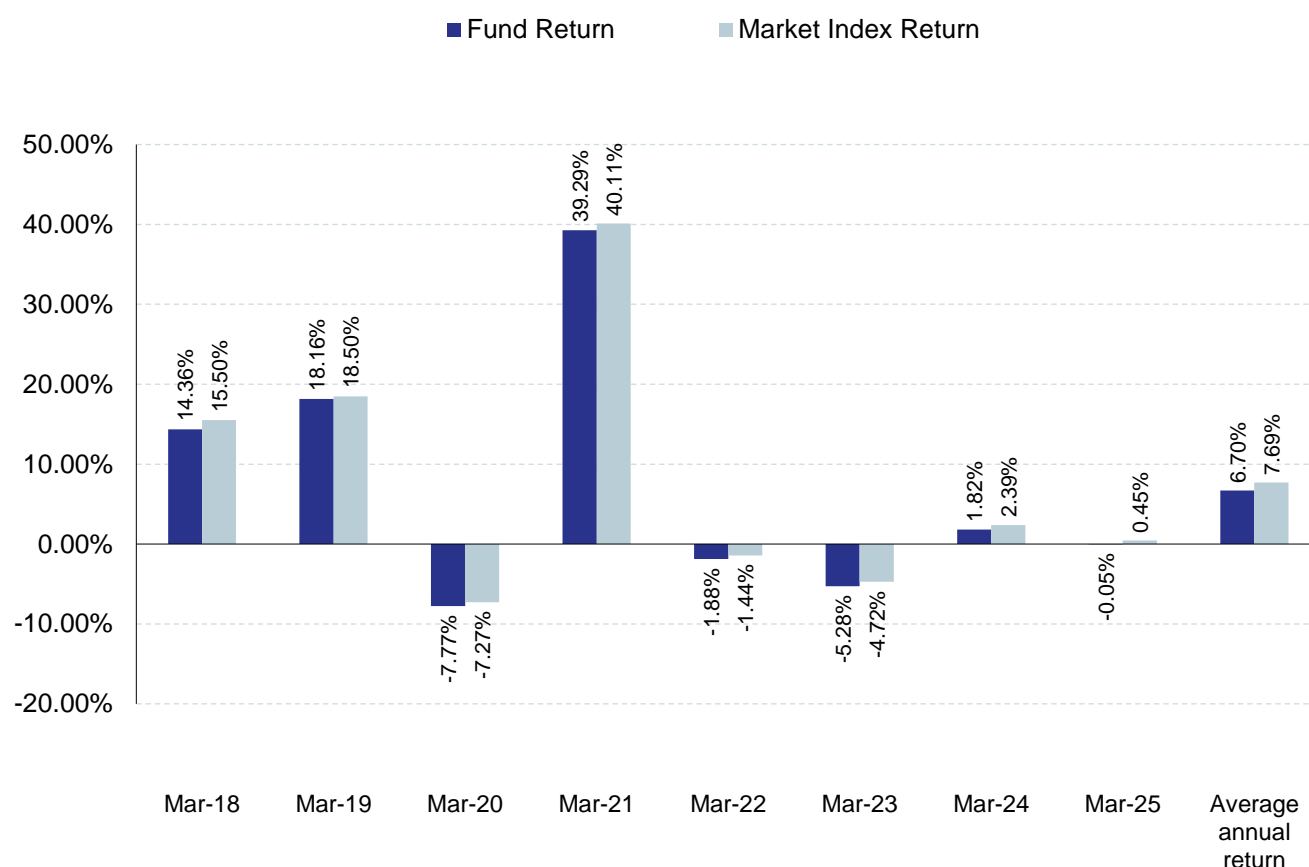

## How has the fund performed?

## What fees are investors charged?

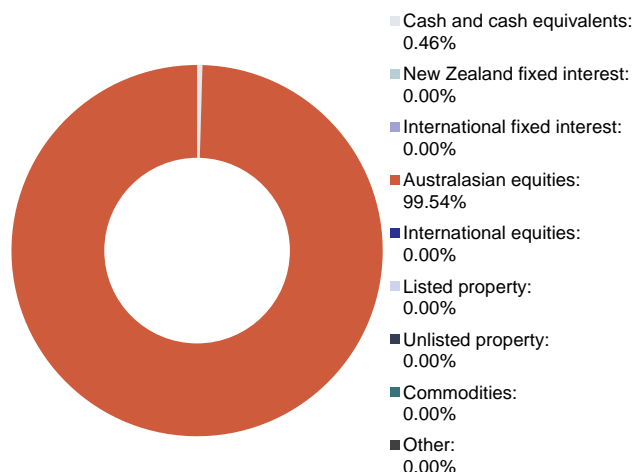
## Example of how this applies to an investor

Tara had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Tara received a return after fund charges were deducted but before tax of \$88 (that is 0.88% of Tara's initial \$10,000). This gives Tara a total loss after tax of -\$5 for the year.
