Description of this fund


The Smart Total World (NZD Hedged) ETF is designed to track the return (before tax, fees and other expenses) of the FTSE Global All Cap Index (100% NZD Hedged). The Index is comprised of financial products of large, mid and small cap companies located around the world. The

currency exposure is hedged to the New Zealand dollar.

What are the risks of investing?

Risk indicator for the Smart Total World (NZD Hedged) ETF¹




How has the fund performed?


Example of how this applies to an investor

Tara had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Tara received a return after fund charges were deducted but before tax of \$643 (that is 6.43% of Tara's initial \$10,000). This gives Tara a total return after tax of \$577 for the year.

Currency hedging

As at 31 March 2025 the fund's exposure to assets denominated in foreign currencies was 97.79%, of which 104.91% was hedged. This means the fund's unhedged foreign currency exposure was 0.00% of the net asset value of the fund. Notes

- These charges refer to the normal fund operating costs that are charged to the fund. For disclosure purposes, supervisor, audit and legal costs are not included in the manager's basic fee, but are included in the other management and administration charges. Some of these are fixed costs so the amount shown can range from 0% up to the total fund charges depending on the total value of the fund.
