# Mercer Macquarie Global Listed Real Estate Fund Mercer Investment Funds

## What is the purpose of this update?

This document tells you how the Mercer Macquarie Global Listed Real Estate Fund has performed and what fees were charged. The document will help you to compare the fund with other funds. 
## **Description of this fund**

The fund invests in a global portfolio of property securities listed on stock exchanges around the world. It aims to generate medium to high returns over the long term by investing in a broad range of property regions, sectors and securities through a single fund. Environmental, Social and Governance characteristics are integrated into the investment process. The fund aims provide a Gross Return<sup>1</sup> above the FTSE EPRA/NAREIT Developed Total Return Index with net dividends reinvested (100% hedged to the NZD on an after-tax basis) on a rolling three-year basis.

## What are the risks of investing?

## Risk indicator for the Mercer Macquarie Global Listed Real Estate Fund:



## Example of how this applies to an investor


Ben had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Ben received a return after fund charges were deducted of \$181.00 (that is 1.81% of his initial \$10,000). Ben also paid \$0.00 in other charges. This gives Ben a total return after tax of \$181.00 for the year.


### Actual investment mix<sup>5</sup>

#### **Currency management**

Hedging coverage, on a net of tax basis, for the fund's exposure to foreign currency as at 31 March 2025 was 104.67%.

## **Notes**

1. Gross Return is the return before the deduction of tax, expense and fees and assumes all income is reinvested.

2. These returns are for the periods ending 31 March 2025.

3. The bar graph shows fund returns after the deduction of fees and tax, however, the market index returns are shown before any fees or tax are deducted.

4. GST is currently charged at 15% on 10% of the management fee in accordance with the non-binding IRD agreement with the Financial Services Council of New Zealand Incorporated on behalf of the funds management industry. GST on management fees is currently under review and therefore this percentage may change in the future.

5. For the reporting of the types of assets under "Actual investment mix", foreign exchange hedging positions have been assigned to the asset class to which they relate.

6. The Top 10 investments have been calculated excluding operational cash and derivatives.
