What is the purpose of this update?

This document tells you how the Mercer Macquarie Global Listed Real Estate Fund has performed and what fees were charged. The document will help you to compare the fund with other funds. 
Description of this fund

The fund invests in a global portfolio of property securities listed on stock exchanges around the world. It aims to generate medium to high returns over the long term by investing in a broad range of property regions, sectors and securities through a single fund. Environmental, Social and Governance characteristics are integrated into the investment process. The fund aims provide a Gross Return¹ above the FTSE EPRA/NAREIT Developed Total Return Index with net dividends reinvested (100% hedged to the NZD on an after-tax basis) on a rolling three-year basis.

What are the risks of investing?

Risk indicator for the Mercer Macquarie Global Listed Real Estate Fund:



The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the fund's assets goes up and down. A higher risk generally means higher potential returns over time, but more ups and downs along the way.



Example of how this applies to an investor


Ben had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Ben received a return after fund charges were deducted of \$181.00 (that is 1.81% of his initial \$10,000). Ben also paid \$0.00 in other charges. This gives Ben a total return after tax of \$181.00 for the year.


Actual investment mix⁵

Currency management

Hedging coverage, on a net of tax basis, for the fund's exposure to foreign currency as at 31 March 2025 was 104.67%.

5. For the reporting of the types of assets under "Actual investment mix", foreign exchange hedging positions have been assigned to the asset class to which they relate.
