What is the purpose of this update?



How has the fund performed?


Example of how this applies to an investor

Sarah had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Sarah received a return after fund charges were deducted of \$701 (that is 7.01% of her initial \$10,000). This gives Sarah a total return after tax of \$701 for the year.

Actual investment mix


This shows the types of assets that the fund invests in.
