## Mercer Responsible Global Shares Fund Mercer Investment Funds

#### What is the purpose of this update?

This document tells you how the Mercer Responsible Global Shares Fund has performed and what fees were charged. The document will help you to compare the fund with other funds. Mercer (N.Z.) Limited prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

### **Description of this fund**

The fund invests in shares listed on international share markets managed within a sustainable approach. The fund is managed to specific 'sustainable investment' criteria which aim to avoid investments in certain companies or activities, and encourage investment in companies with strong environmental, social and governance characteristics. This fund has additional exclusions applied as described in our Sustainable Investment Policy and has been certified by the Responsible Investment Association of Australasia (RIAA).

The fund aims to outperform the MSCI World Index with net dividends reinvested (50% hedged to NZD on an aftertax basis) on a rolling five-year basis.

## What are the risks of investing? Risk indicator for the Mercer Responsible Global Shares Fund:



#### Example of how this applies to an investor


Ben had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Ben received a return after fund charges were deducted of \$652.00 (that is 6.52% of his initial \$10,000). Ben also paid \$0.00 in other charges. This gives Ben a total return after tax of \$652.00 for the year.


#### Actual investment mix<sup>5</sup>

The top 10 investments make up 22.53% of the fund.

#### **Currency management**

The fund targets a position of being 69% gross hedged to the New Zealand dollar. The hedges are based on the currency weights of the underlying index. Currency hedges are normally rebalanced monthly but may be adjusted intra-month for significant cash flows. See the Statement of Investment Policy and Objectives on the scheme register at **www.disclose-register.companiesoffice.govt.nz** for more information about currency management.

Hedging coverage, on a net of tax basis, for the fund's exposure to foreign currency as at 31 March 2025 was 50.70%.

#### Notes

1. These returns are for the periods ending 31 March 2025.

2. The after-tax return is higher than the pre-tax return over this period as a result of volatile tax obligations attributed to the investments during the year. The impact of tax credits this way is uncommon and should not be expected.

3. The bar graph shows fund returns after the deduction of fees and tax, however, the market index returns are shown before any fees or tax are deducted.

4. GST is currently charged at 15% on 10% of the management fee in accordance with the non-binding IRD agreement with the Financial Services Council of New Zealand Incorporated on behalf of the funds management industry. GST on management fees is currently under review and therefore this percentage may change in the future.

5. For the reporting of the types of assets under "Actual investment mix", foreign exchange hedging positions have been assigned to the asset class to which they relate.

6. The Top 10 investments have been calculated excluding operational cash and derivatives.
