WHAT IS THE PURPOSE OF THIS UPDATE?

This document tells you how the QuayStreet High Growth Fund has performed and what fees were charged. The document will help you to compare the fund with other funds. DESCRIPTION OF THIS FUND

The QuayStreet High Growth Fund invests in a diversified portfolio with a greater emphasis on growth assets. The investment objective is to provide a level of return above the Fund's benchmark over the long term.

WHAT ARE THE RISKS OF INVESTING?

EXAMPLE OF HOW THIS APPLIES TO AN INVESTOR


Small differences in fees and charges can have a big impact on your investment over the long term.

Emma had \$10,000 in the fund on 19 April 2024 and did not make any further contributions. On 31 March 2025, Emma received a return after fund charges were deducted but before tax of \$1,273 (that is 12.73% of Emma's initial \$10,000). Emma also paid \$34.40 in other charges. This gives Emma a total loss after tax of \$1,132 for the period.

Currency Hedging

The fund's foreign currency exposure is actively managed in a manner consistent with the investment objectives and the performance benchmark of the fund. As at March 31 2025, the fund's exposure to assets denominated in foreign currencies was 84.86%, of which 17.55% was hedged. This means the fund's unhedged foreign currency exposure was 69.97% of the net asset value of the fund. See the current SIPO on the offer register at disclose-

NOTES
