What is the purpose of this update?

What are the risks of investing?

The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the fund's assets goes up and down. A higher risk generally means higher potential returns over time, but more ups and downs along the way.



What fees are investors charged?

Investors in the New Zealand Growth Fund are charged fund charges that include GST. In the year to 31 March 2024 these were:

(i) Example of how this applies to an investor

fisherfunds

Katie had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Katie received a return after fund charges were deducted of \$2,455 (that is 24.55% of her initial \$10,000). Katie did not pay other charges. This gives Katie a total return after tax of \$2,455 for the year.


Annual return graph



What does the fund invest in?


Actual investment mix
