This fund update was first made publicly available on 1 May 2025.

What is the purpose of this update?

This document tells you how the Kernel NZ 20 Fund has performed and what fees were charged. The document will help you to compare the fund with other funds. Kernel Wealth Limited prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

Description of this fund

The Kernel NZ 20 Fund invests in financial products listed on the NZX and is designed to track the S&P/NZX 20 Index.

The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the fund's assets goes up and down. 


Investors are not charged individual action fees for specific actions or decisions (for example, for withdrawing from funds). All fees are inclusive of GST.

Example of how this applies to an investor

Emma had \$10,000 in the fund on 1 April 2024 and did not make any further contributions. On 31 March 2025, Emma received a return after fund charges were deducted of \$90 (that is 0.9% of her initial \$10,000). This gives Emma a total return after tax of \$4 for the period.
