### What is the purpose of this update?

This document tells you how the Smart Europe ETF has performed and what fees were charged. The document will help you to compare the fund with other funds. ### **Description of this fund**

The Smart Europe ETF is designed to track the return (before tax, fees and other expenses) of the FTSE Developed Europe All Cap Index. The Index is comprised of large, mid and small cap companies located in European countries.

# What are the risks of investing?

#### **Risk indicator for the Smart Europe ETF**




### Example of how this applies to an investor

Tara had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Tara received a return after fund charges were deducted but before tax of \$1,448 (that is 14.48% of Tara's initial \$10,000). This gives Tara a total return after tax of \$1,302 for the year.
