
### **Description of this fund**

The Smart NZ Property ETF is designed to track the return (before tax, fees and other expenses) of the S&P/NZX Real Estate Select Index. The Index is comprised of the largest and most liquid members of the S&P/NZX All Index classified under the GICS Real Estate Industry Group.

## What are the risks of investing?

#### **Risk indicator for the Smart NZ Property ETF**



The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the fund's assets goes up and down. A higher risk generally means higher potential returns over time, but more ups and downs along the way.




### How has the fund performed?


### Example of how this applies to an investor

Tara had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Tara incurred a loss after fund charges were deducted but before tax of -\$274 (that is -2.74% of Tara's initial \$10,000). This gives Tara a total loss after tax of -\$330 for the year.
