## External fund manager descriptions

The descriptions of the external fund managers of our underlying single-asset-class funds are as follows:

Fund manager	Description
<b>BlackRock Investment Management</b>	BlackRock Investment Management (Australia) Limited (BlackRock) manages a portfolio of international equities. BlackRock evaluates companies across style factor characteristics such as quality, value, momentum, low volatility and size to form an expected return, then invests in a selection of those companies with the best combined expected return.
<b>LSV Asset Management</b>	LSV Asset Management (LSV) manages a portfolio of international equities. LSV aims to invest in out-of-favour or undervalued stocks that have the potential for near-term appreciation.
<b>Maple-Brown Abbott</b>	Maple-Brown Abbott (MBA) manages a portfolio of international listed infrastructure securities. MBA targets infrastructure assets that they believe have a high degree of inflation protection, low cash flow volatility and strong corporate governance.
<b>Northern Trust Investments, Inc.</b>	Northern Trust Investments, Inc. (Northern Trust) manages portfolios of international fixed interest assets issued by governments and global corporates, and international equities. Government bonds are managed to follow a custom index while global corporate bonds and international equities are selected based on quality, value and ESG considerations.
<b>PIMCO Australia Pty Limited</b>	PIMCO Australia Pty Limited (PIMCO) manages a portfolio of international fixed interest assets issued by a variety of issuers including governments, government agencies, companies and banks. PIMCO conducts extensive research and analysis to continuously monitor economic and market trends and identify what they believe are the best opportunities between and within each asset type.
<b>Resolution Capital Limited</b>	Resolution Capital Limited (Resolution Capital) manages a select and diverse group of global listed property assets that they believe are capable of generating superior risk adjusted returns for investors.
<b>The Franklin Equity Group</b>	The Franklin Equity Group (Franklin), a part of Franklin Templeton Investments, manages a portfolio of international equities. Franklin aims to invest in quality companies with the potential to produce sustainable earnings and cash flow growth.
<b>Tyndall Asset Management</b>	Tyndall Asset Management uses an investment style that seeks to identify good value stocks that offer the best compromise between risk and expected return.
<b>Vontobel Asset Management Inc</b>	Vontobel Asset Management Inc (Vontobel) manages a portfolio of international equities. Vontobel aims to invest in sensibly priced, high-quality companies that can grow earnings faster than the market on a sustainable basis.
