

QuayStreet Socially Responsible Investment Fund

1. WHAT IS THE PURPOSE OF THIS UPDATE?

This document tells you how the QuayStreet Socially Responsible Investment Fund (SRI Fund) has performed and what fees were charged. The document will help you to compare the fund with other funds. Smartshares Limited prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

2. DESCRIPTION OF THIS FUND

The guiding philosophy of the SRI Fund is to endeavour to have a diversified portfolio of investments that are considered to be environmentally and socially sustainable, whilst still applying our traditional portfolio investment criteria. The fund invests in fixed interest and growth assets which are selected in accordance with our Socially Responsible Investment Policy (SRI Policy). 3. WHAT ARE THE RISKS OF INVESTING?

The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the fund's assets goes up and down. A higher risk generally means higher potential returns over time, but more ups and downs along the way.



DESCRIPTION OF HOW CHARGE IS CALCULATED

Administration Fee	Up to \$30 per annum per member charged to your member account.
Scheme Expenses	Approximately \$6.42 per annum per member. This estimate has been based on the total amount of costs and expenses recovered during the scheme's previous financial year on a per member basis. The actual expenses incurred will vary from time to time and are recovered on a per member basis

6. EXAMPLE OF HOW THIS APPLIES TO AN INVESTOR

Small differences in fees and charges can have a big impact on your investment over the long term.

Emma had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Emma received a return after fund charges were deducted but before tax of \$1424 (that is 14.24% of Emma's initial \$10,000). Emma paid other charges of \$36.42. This gives Emma a total return after tax of \$1257 for the year.



The Top 10 investments make up 27.84% of the net asset value of the fund.

CURRENCY HEDGING – The fund's foreign currency exposure is actively managed in a manner consistent with the investment objectives and the performance benchmark of the fund. As at 31 December 2023, the fund's exposure to assets denominated in foreign currencies was 55.68%, of which 11.7% was hedged. This means the fund's unhedged foreign currency exposure was 43.98% of the net asset value of the fund.
