### What is the purpose of this update?

This document tells you how the Growth Fund has performed and what fees were charged. The document will help you to compare the fund with other funds. The fund aims to grow your investment over the long term by investing mainly in growth assets.

# What are the risks of investing?

Risk indicator for the Growth Fund:



The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the fund's assets goes up and down. A higher risk generally means higher potential returns over time, but more ups and downs along the way.



# How has the fund performed?

Investors in the Growth Fund are charged fund charges. In the year to 31 March 2024 these were:


# Example of how this applies to an investor

Sarah had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Sarah received a return after fund charges were deducted of \$235 (that is 2.35% of her initial \$10,000). This gives Sarah a total return after tax of \$235 for the year.


