### What is the purpose of this update?


# How has the fund performed?

## Annual return graph

#### What fees are investors charged?

Investors in the New Zealand Growth Fund are charged fund charges that include GST. In the year to 31 March 2025 these were:

# Example of how this applies to an investor


Katie had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Katie received a return after fund charges were deducted of \$1,246 (that is 12.46% of her initial \$10,000). Katie did not pay other charges. This gives Katie a total return after tax of \$1,246 for the year.
