Estimated default rates by risk grade

Each loan in the marketplace has an estimated default rate based on its risk grade. It is important to understand that this is an estimated rate and the actual default rate may vary from the rate shown. Information about actual default rates will be published as they become available.

The table below shows the estimated annual default rate for applications approved after 6 November 2019, under scorecard 1.6.
