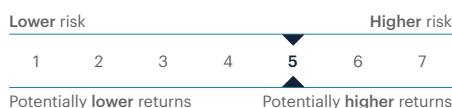
### Description of this Fund

The fund focuses on growth of your investment over the long term by investing in New Zealand and international shares.

### What are the risks of investing?

Risk indicator for the Equity Fund:



The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the fund's assets goes up and down. A higher risk generally means higher potential returns over time, but more ups and downs along the way.

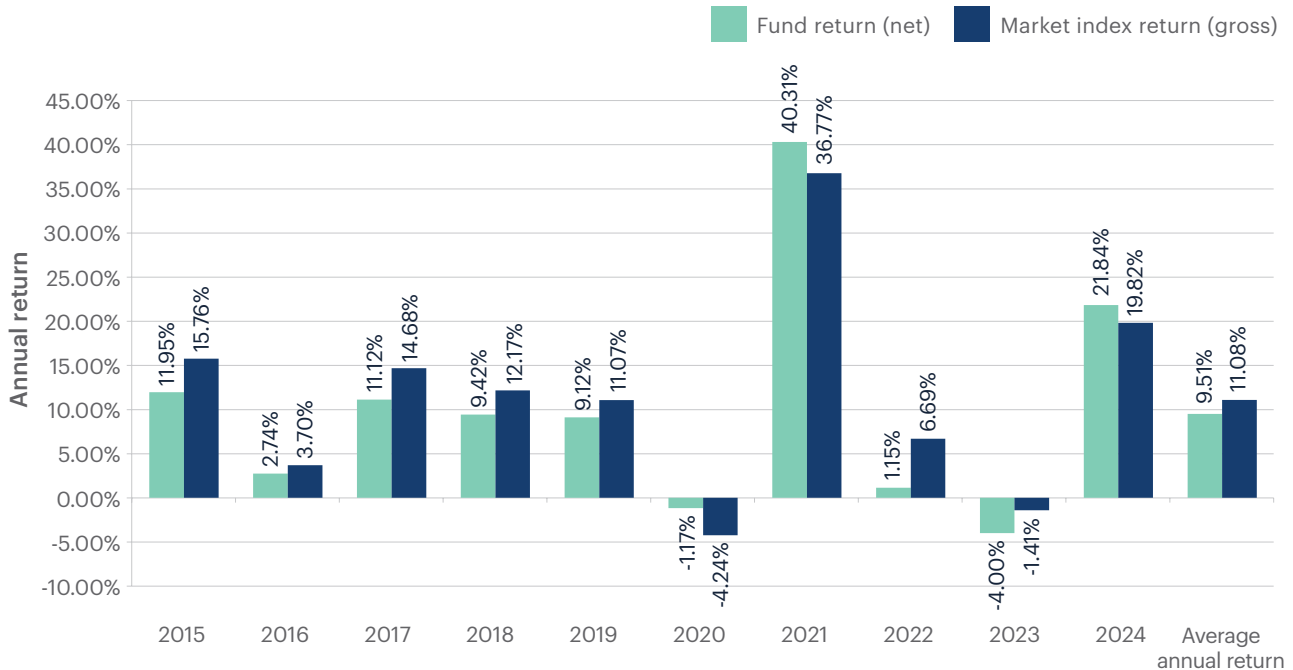

### How has the fund performed?

## Annual return graph



This shows the return after fund charges and tax for the last 10 years ending 31 March. The last bar shows the average annual return for the last 10 years, up to 31 December 2024.

Returns in this update are after tax at the highest prescribed investor rate (PIR) of tax for an individual New Zealand resident. Your tax may be lower. The market index return reflects no deduction for charges and tax.

## What fees are investors charged?

Investors in the Equity Fund are charged fund charges. In the year to 31 March 2024 these were:

Small differences in fees and charges can have a big impact on your investment over the long term.



### Example of how this applies to an investor

Jen had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Jen received a return after fund charges were deducted of \$1,838 (that is 18.38% of her initial \$10,000). This gives Jen a total return after tax of \$1,838 for the year.

## What does the fund invest in?

### Actual investment mix
