This is a replacement fund update. It replaces the previous fund update for the quarter ending 30 June 2025, first made publicly available on 28 July 2025. This replacement has corrected the market index annual return in the past year in the "How has the fund performed?" section.

What is the purpose of this update?

This document tells you how the Foundation Series High Growth Fund has performed and what fees were charged. The document will help you to compare the fund with other funds. FundRock NZ Limited prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

Description of this fund

Objective: The fund aims to perform broadly in line with the return of its investment benchmark before fees and tax over the long-term.

Strategy: Aims for high long-run returns by investing in a diversified portfolio of predominantly growth assets but with a small amount of income asset exposure. The Fund incorporates certain responsible investment considerations and is exposed to investment strategies that seek to exclude companies involved in particular business practices.

Risk indicator for the Foundation Series High Growth Fund.



The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the fund's assets goes up and down. A higher risk generally means higher potential returns over time, but more ups and downs along the way.

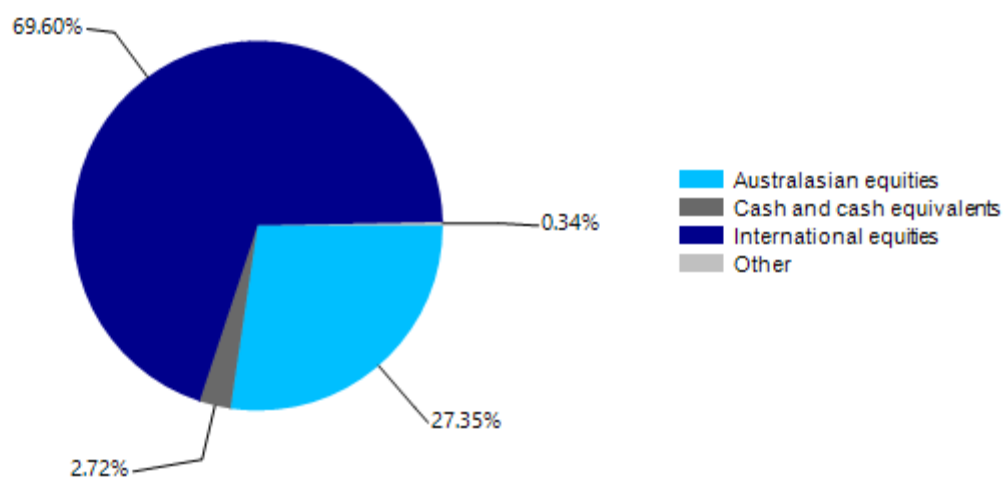
Small differences in fees and charges can have a big impact on your investment over the long term.

Anthony had \$10,000 in the fund when the fund received its first contribution, 04 March 2025 and did not make any further contributions. At the end of the period to 30 June 2025, Anthony received a return after fund charges were deducted of \$273 (that is 2.73% of his initial \$10,000). This gives Anthony a return after tax of \$234 for the period.

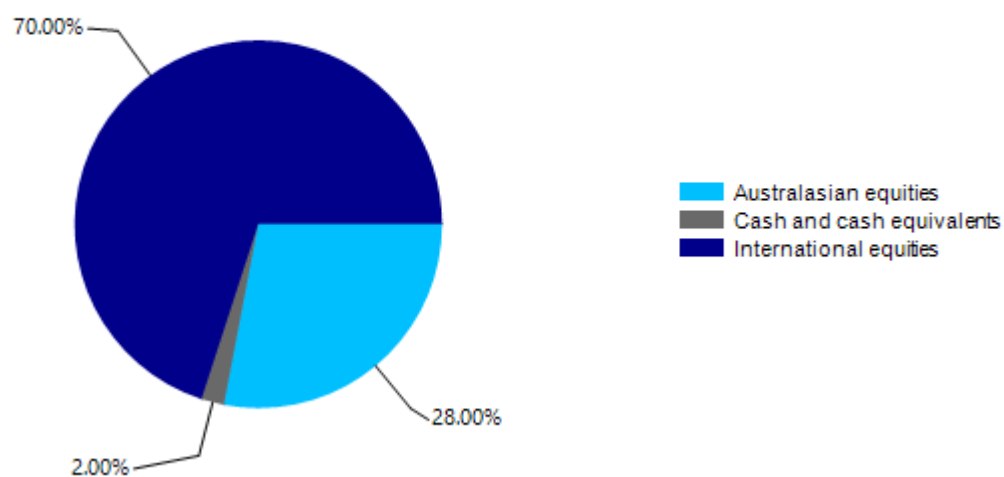
Actual Investment Mix

Notes

1. A combination of actual fund returns and market index returns have been used to determine the risk indicator as the fund has not been operating for the required five years. The risk indicator may therefore provide a less reliable indicator of the fund's future volatility.
