What is the purpose of this update?

This document tells you how the Positive Impact Fund has performed and what fees were charged. The document will help you to compare the fund with other funds. ASB Group Investments Limited prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

Description of this fund

To invest in a portfolio of investments that make a positive impact on society or the environment while seeking to provide moderate to high long-term returns allowing for large movements of value up and down. The number of years with negative returns are generally expected to be similar to the Growth Fund in the ASB KiwiSaver Scheme. The impact objective is to achieve measurable positive outcomes in line with the UN Sustainable Development Goals. The Positive Impact Fund invests in income and growth assets with a target investment mix of 40% income assets and 60% growth assets.

What are the risks of investing?

Risk indicator for Positive Impact Fund¹



¹As the fund has not been in existence for five full years its risk indicator has been calculated using market index returns as well as actual returns. As a result, the risk indicator may provide a less reliable indicator of the potential future volatility of the fund. Market index returns have been used for the period from 1 January 2019 to 24 July 2019.

The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the fund's assets goes up and down. A higher risk generally means higher potential returns over time, but more ups and downs along the way.



Small differences in fees and charges can have a big impact on your investment over the long term.


Example of how this applies to an investor

Jason had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Jason received a return after fund charges were deducted of \$672.00 (that is 6.72% of his initial \$10,000). Jason also paid \$0.00 in other charges. This gives Jason a total return after tax of \$672.00 for the year.

Currency hedging

As at 31 December 2023 the fund's exposure to assets denominated in foreign currencies was 96%, of which 71% was hedged. This means the fund's unhedged foreign currency exposure was 28% of the net asset value of the fund.
