What is the purpose of this update?

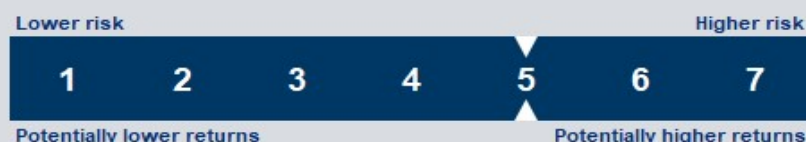
Description of this fund

Invests almost entirely in growth assets such as shares and real assets, with only a small amount invested in defensive assets such as fixed interest and cash. May be suitable for investors wanting to invest predominantly in growth assets, who want higher long-term returns and are comfortable with high volatility in returns. This fund is managed with reference to environmental, social and governance (ESG) factors and is certified by the Responsible Investment Association of Australasia.

What are the risks of investing?

Risk indicator for the Sustainable High Growth fund:[†]



The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the fund's assets goes up and down. A higher risk generally means higher potential returns over time, but more ups and downs along the way.

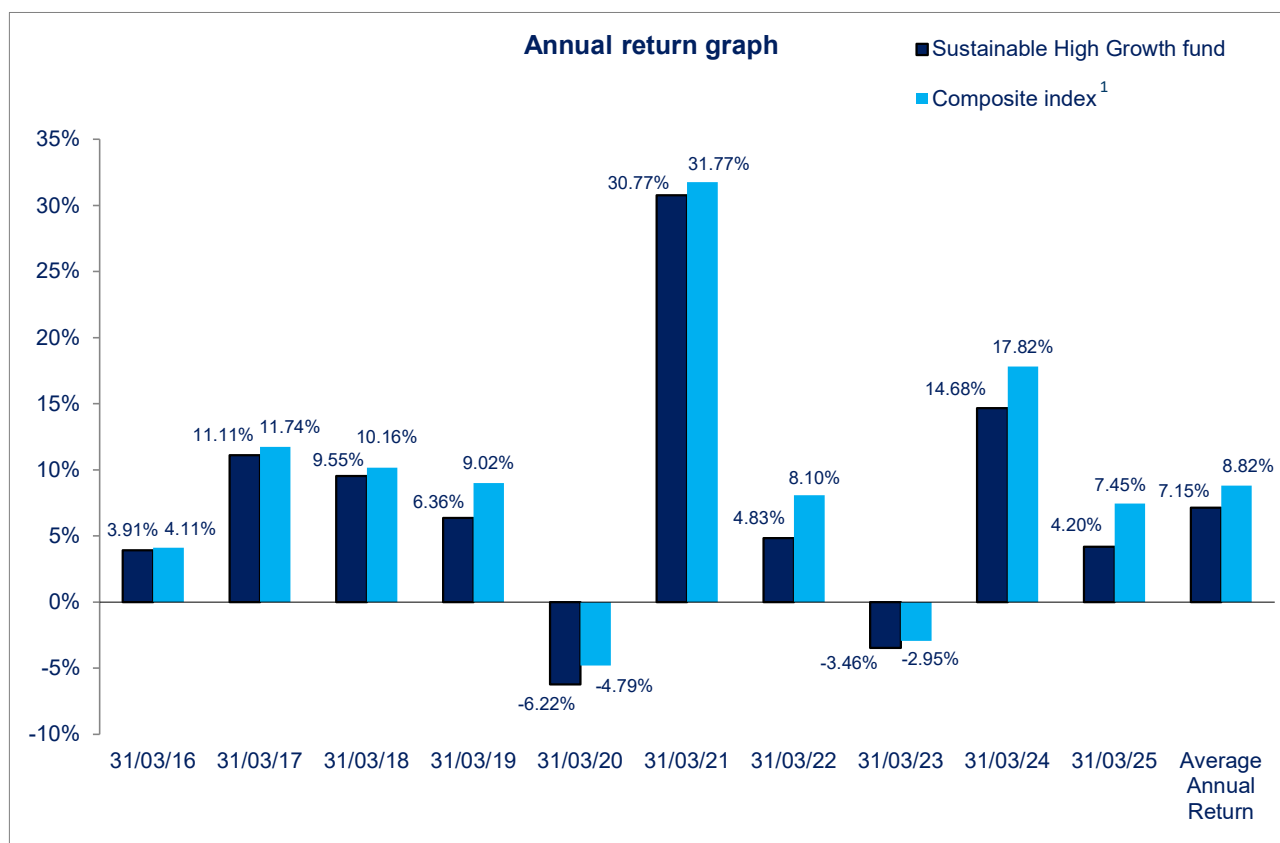

How has the fund performed?

Small differences in fees and charges can have a big impact on your investment over the long term.

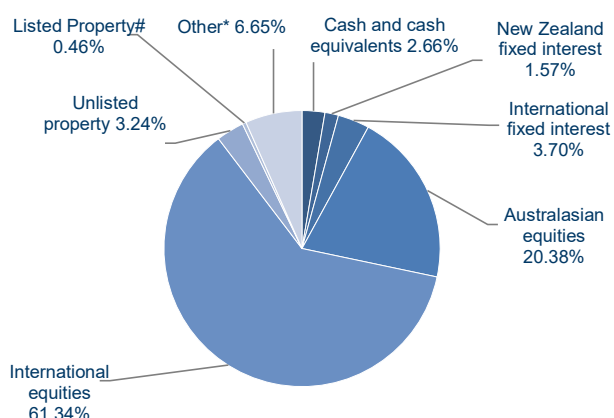
Example of how this applies to an investor

Ben had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Ben received a return after fund charges were deducted of \$420.00 (that is 4.20% of his initial \$10,000). Ben also paid \$0.00 in other charges. This gives Ben a total return after tax of \$420.00 for the year.

This shows the types of assets that the fund invests in.⁴

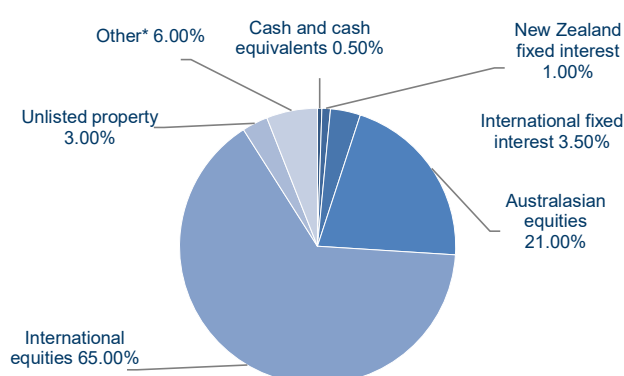

Following changes to the strategic asset allocation, the fund no longer holds a Strategic Asset allocation to Listed Property. We continue to invest in Listed Property as a Dynamic Asset Allocation tilt.

Currency hedging

Currency hedging can apply to some of the asset classes this fund invests in. The level of currency hedging for global shares is managed between 0% and 100% on a net of tax basis and may change over time depending on Mercer's view of the relative strength (or weakness) of the New Zealand dollar. Other global asset classes (Global Fixed Interest and Real Assets) target a 100% net of tax hedge to the New Zealand dollar. Hedging coverage, on a net of tax basis, for the Fund's exposure to foreign currency as at 31 March 2025 was 59.22%.

Notes

1. The benchmark is a composite of market, peer group and absolute return indices. The absolute return indices were used up to 30 September 2018. From 30 September 2018 a composite has been used as there is no appropriate market index for the fund as a whole and market indices are not applicable for some of the asset classes in this fund. The composite index has been used in the table and bar graph in the *How has the fund performed?* section. The composite index may be a less reliable indicator of performance than a market index. The peer group indices returns reflected in the table and the bar graph are after deductions for charges but before tax.
