### What is the purpose of this update?

This document tells you how the International Property Fund has performed and what fees were charged. The document will help you to compare the fund with other funds. ### Description of this fund

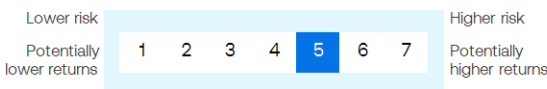
The International Property Fund invests mainly in international listed property assets. Investments may include companies, funds or trusts that invest in property and are listed or are soon to be listed, and cash and cash equivalents.

The International Property Fund aims to achieve a return (after the fund charge and before tax) that over the long-term outperforms the relevant market index.

### What are the risks of investing?

Risk indicator for the International Property Fund:

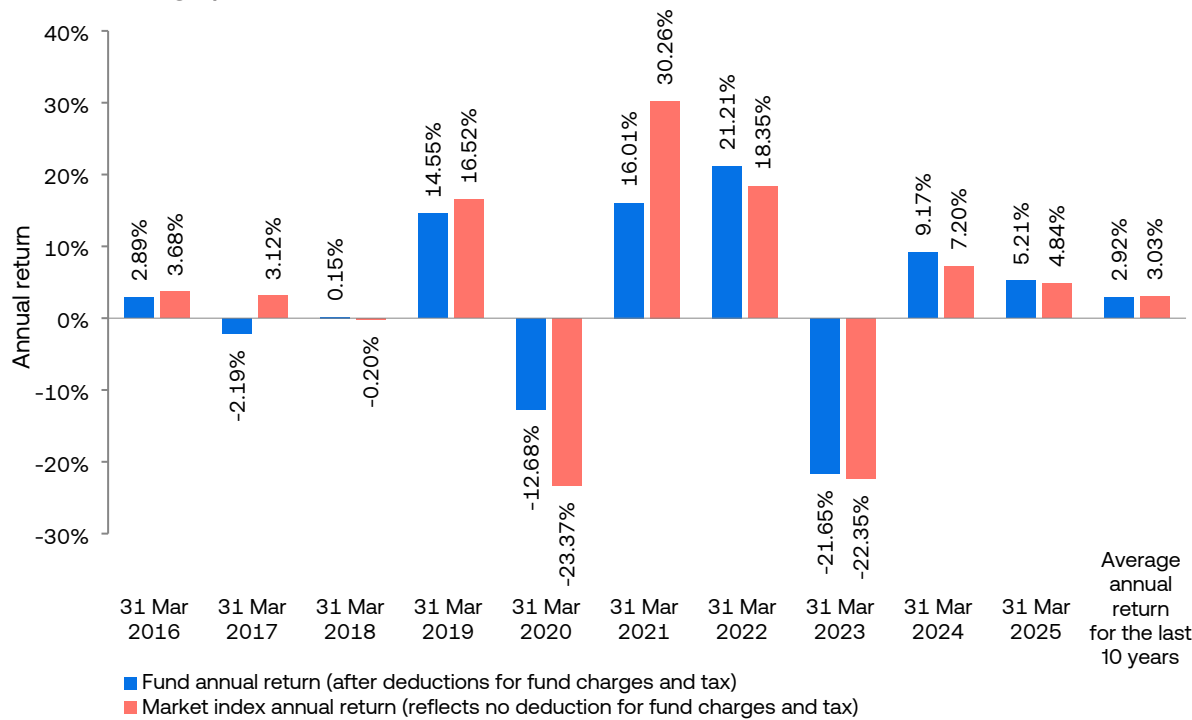

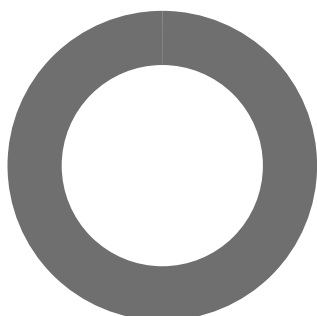
### Example of how this applies to an investor

Sarah had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Sarah received a return after fund charges were deducted of \$443 (that is 4.43% of her initial \$10,000). Sarah did not pay any other charges. This gives Sarah a total return after tax of \$443 for the year.

### Actual investment mix<sup>2</sup>

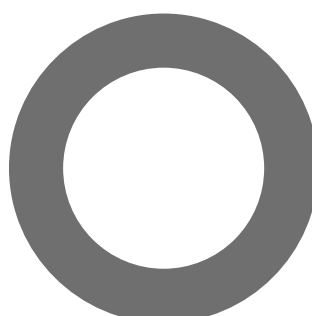
This shows the types of assets that the fund invests in.
