What is the purpose of this update?

This document tells you how the InvestNow Generate Focused Growth Fund has performed and what fees were charged. The document will help you to compare the fund with other funds. FundRock NZ Limited prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

Description of this fund

Objective: aims to provide a higher growth investment return over the long term through investment in nearly all growth assets.

Strategy: provides exposure to a diversified fund that invests into a portfolio weighted toward growth assets, but with a small allocation to income assets.

Example of how this applies to an investor

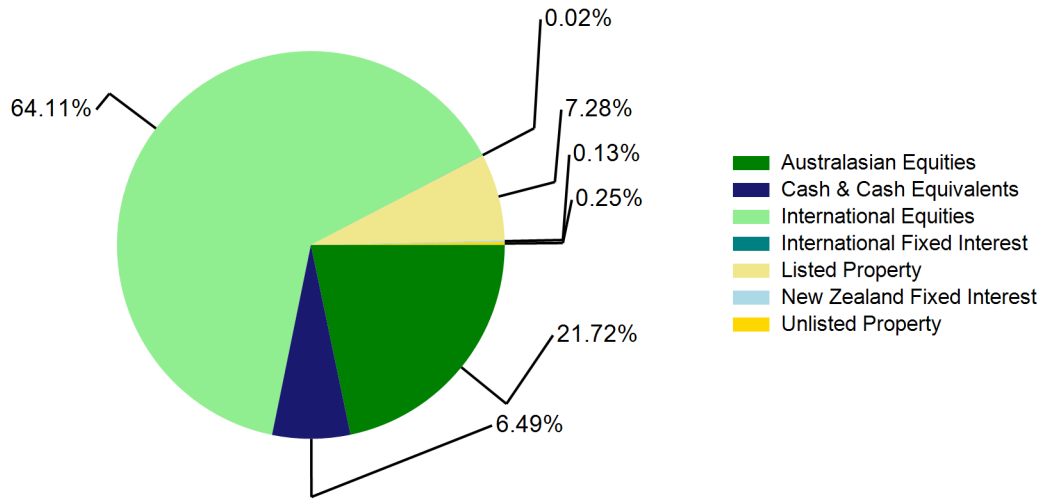
Small differences in fees and charges can have a big impact on your investment over the long term.

Anthony had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Anthony received a return after fund charges were deducted of \$2,460 (that is 24.60% of his initial \$10,000). This gives Anthony a total return after tax of \$2,299 for the period.

This shows the types of assets that the fund invests in.

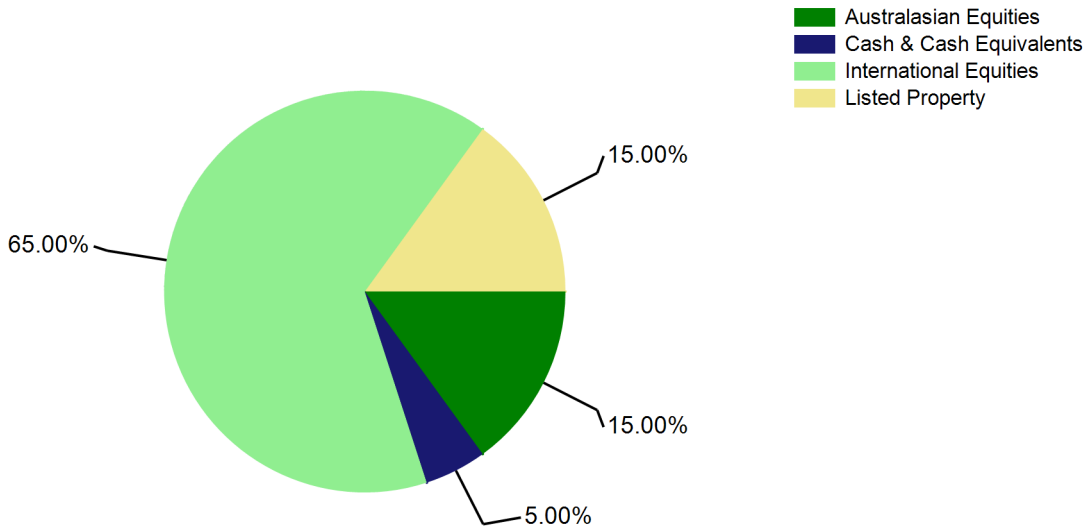
Actual Investment Mix

The fund's net foreign currency exposure was 34.93% of net asset value on the 30 September 2024. At target the fund's net foreign currency exposure is 32.50% of net asset value.

Notes

- i. A combination of actual fund returns and market index returns have been used to determine the risk indicator as the fund has not been operating for the required five years. - ii. As the InvestNow Generate Focused Growth Fund only started accepting contributions on 1 May 2023 historical fee information is not available.
