What is the purpose of this update?

This document tells you how GlidePath Age 75 has performed and what fees were charged. The document will help you to compare the fund with other funds. Fisher Funds Management Limited prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

Description of this Fund

GlidePath Age 75 is a representation of the GlidePath life cycle. This investment option invests 92% in the Conservative Fund and 8% in the Preservation Fund.


How has the fund performed?

Small differences in fees and charges can have a big impact on your investment over the long term.




Example of how this applies to an investor

Jen had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Jen received a return after fund charges were deducted of \$522 (that is 5.22% of her initial \$10,000). This gives Jen a total return after tax of \$522 for the year.

Actual investment mix


This shows the types of assets that the fund invests in.
