
DESCRIPTION OF THIS FUND

The QuayStreet Income Fund will invest in a diversified portfolio with an emphasis on income producing assets such as New Zealand and International fixed interest investments and derivatives. The fund may include an allocation to growth assets. The investment objective is to provide a level of return above the fund's benchmark over the long term. The fund aims to make quarterly distributions.

WHAT ARE THE RISKS OF INVESTING?

Risk indicator for the QuayStreet Income Fund



EXAMPLE OF HOW THIS APPLIES TO AN INVESTOR

Small differences in fees and charges can have a big impact on your investment over the long term.

Emma had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Emma received a return after fund charges were deducted but before tax of \$629 (that is 6.29% of Emma's initial \$10,000). This gives Emma a total return after tax of \$440 for the year.

Currency Hedging

The fund's foreign currency exposure is actively managed in a manner consistent with the investment objectives and the performance benchmark of the fund. As at 31 March 2025, the fund's exposure to assets denominated in foreign currencies was 48.58%, of which 99.81% was hedged. This means the fund's unhedged foreign currency exposure was 0.09% of the net asset value of the fund.
