What is the purpose of this update?

This document tells you how the SBS Wealth Income Fund has performed and what fees were charged. The document will help you to compare the fund with other funds. SBS Wealth Limited prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

Description of this fund

The fund aims to provide investors with a low-risk investment option that invests predominantly in income producing assets, the majority of these being cash and fixed interest investments. The Fund may also hold high dividend yielding equities and/or listed property and infrastructure investments.

What are the risks of investing?

Risk indicator for the SBS Wealth Income Fund:



The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the fund's assets goes up and down. A higher risk generally means higher potential returns over time, but more ups and downs along the way.


How has the fund performed?


Example of how this applies to an investor

Hayley had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Hayley received a return after fund charges were deducted of \$430 (that is 4.30% of her initial \$10,000). This gives Hayley a total return after tax of \$294.00 for the year.

The top 10 investments make up 93.00% of the net asset value of the fund.

Currency hedging

As at 31 March 2025 the fund has an exposure to foreign currency assets of 61.04%, of which 61.04% was hedged back to NZD. This means the fund’s foreign currency exposure is 0.00%.
