What is the purpose of this update?

This document tells you how the Mercer NZ Shares Passive Fund has performed and what fees were charged. The document will help you to compare the fund with other funds. Mercer (N.Z.) Limited prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

Description of this fund

The fund is a passively managed New Zealand shares portfolio that is designed to track the return of the S&P/NZX 50 Index. Environmental, Social and Governance characteristics are integrated into the underlying investment managers' investment processes. The fund aims to provide a return that closely matches the return of the S&P/NZX 50 Index (on a gross basis and including imputation credits).

Total value of the fund \$140,663,073

The date the fund started 27 November 2017

What are the risks of investing?

Risk indicator for the Mercer NZ Shares Passive Fund:



The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the fund's assets goes up and down. A higher risk generally means higher potential returns over time, but more ups and downs along the way.



Example of how this applies to an investor


Ben had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Ben received a return after fund charges were deducted of \$136.00 (that is 1.36% of his initial \$10,000). Ben also paid \$0.00 in other charges. This gives Ben a total return after tax of \$136.00 for the year.


Actual investment mix
