What is the purpose of this update?

This document tells you how the Australian Growth Fund has performed and what fees were charged. The document will help you to compare the fund with other funds. What are the risks of investing?

Risk indicator for the Australian Growth Fund:



The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the fund's assets goes up and down. A higher risk generally means higher potential returns over time, but more ups and downs along the way.

How has the fund performed?



Annual return graph



This shows the return after fund charges and tax for the last 10 years ending 31 March. The last bar shows the average annual return for the last 10 years, up to 31 December 2023.

Example of how this applies to an investor


Katie had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Katie received a return after fund charges were deducted of \$2,318 (that is 23.18% of her initial \$10,000). Katie did not pay other charges. This gives Katie a total return after tax of \$2,318 for the year.



What does the fund invest in?


Actual investment mix

Currency hedging

The benchmark currency hedge ratio for Australian equities is 70% hedged into NZD. At quarter end the fund was 68.4% hedged into NZD.
