
First Home Mortgage Fund (FHMF)

Simplicity NZ Limited (Simplicity) has prepared this additional information in accordance with the Financial Markets Conduct (Managed Funds - Loan Disclosure Requirements) Exemption Notice 2019.

As at 31 December 2022, the Simplicity KiwiSaver Scheme held the following investments in the FHMF:

Asset types:

Residential - secured loans for which the secured property is residential property

Cash - cash on call at a registered NZ bank

The FHMF does not invest in loans secured by commercial property or rural property.

Secured properties must be freehold or cross lease residential properties that the borrower is living in.
