What is the purpose of this update?

This document tells you how the Smart US Large Value ETF has performed and what fees were charged. The document will help you to compare the fund with other funds. Description of this fund

The Smart US Large Value ETF is designed to track the return (before tax, fees and other expenses) of the CRSP US Large Cap Value Index. The Index is comprised of large US value companies.

What are the risks of investing?

Risk indicator for the Smart US Large Value ETF




How has the fund performed?


Example of how this applies to an investor

Tara had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Tara received a return after fund charges were deducted but before tax of \$1,964 (that is 19.64% of Tara's initial \$10,000). This gives Tara a total return after tax of \$1,812 for the year.
