
The fund aims to achieve a positive yearly return (after the fund charge and before tax) that over the long-term is broadly in line with the relevant market index.

#### WHAT ARE THE RISKS OF INVESTING?



#### **EXAMPLE OF HOW THIS APPLIES TO AN INVESTOR**

At the end of the year, Sarah received a return after fund charges were deducted of \$119 (that is 1.19% of her initial \$10,000). Sarah did not pay any other charges. This gives Sarah a total return after tax of \$119 for the year.




# Actual investment mix<sup>2</sup>
