#### What is the purpose of this update?

This document tells you how the New Zealand Growth Fund has performed and what fees were charged. The document will help you to compare the fund with other funds. The fund focuses on growth of your investment over the long term by investing in quality New Zealand companies which can consistently produce increasing earnings.

#### What are the risks of investing?


### How has the fund performed?

#### What fees are investors charged?

Investors in the New Zealand Growth Fund are charged fund charges that include GST. In the year to 31 March 2024 these were:


Katie had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Katie received a return after fund charges were deducted of \$907 (that is 9.07% of her initial \$10,000). Katie did not pay other charges. This gives Katie a total return after tax of \$907 for the year.


#### **Actual investment mix**
