
## **Description of this fund**

The Smart Australian Dividend ETF is designed to track the return (before tax, fees and other expenses) of the S&P/ASX Dividend Opportunities Index. The Index is comprised of 50 high yielding companies listed on the ASX and included in the S&P/ASX 300 Index.

# Risk indicator for the Smart Australian Dividend ETF




## How has the fund performed?


## Example of how this applies to an investor

Tara had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Tara received a return after fund charges were deducted but before tax of \$1,658 (that is 16.58% of Tara's initial \$10,000). This gives Tara a total return after tax of \$1,491 for the year.
