What is the purpose of this update?

The fund aims to provide stable returns over the long term by investing mainly in income assets with a small allocation to growth assets.



How has the fund performed?

What fees are investors charged?

Investors in the Core Conservative Fund are charged fund charges. In the year to 31 March 2025 these were:

Example of how this applies to an investor


Alice had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Alice received a return after fund charges were deducted of \$451 (that is 4.51% of her initial \$10,000). This gives Alice a total return after tax of \$451 for the year.



What does the fund invest in?


Actual investment mix
