What is the purpose of this update?

This document tells you how the Mercer Emerging Markets Shares Fund has performed and what fees were charged. The document will help you to compare the fund with other funds. Mercer (N.Z.) Limited prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

Description of this fund

The fund invests in shares listed on share markets in emerging economies. The portfolio is managed using a single manager. Environmental, Social and Governance characteristics are integrated into the underlying investment managers' investment processes. The fund aims to provide a Gross Return¹ above the MSCI Emerging Market ex Tobacco Index with net dividends reinvested on a rolling three to five-year basis.

Total value of the fund \$5,489,318

The date the fund started 1 November 2007

What are the risks of investing? Risk indicator for the Mercer Emerging Markets Shares Fund:



The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the fund's assets goes up and down. A higher risk generally means higher potential returns over time, but more ups and downs along the way.



Example of how this applies to an investor

Ben had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Ben received a return after fund charges were deducted of \$881.00 (that is 8.81% of his initial \$10,000). Ben also paid \$0.00 in other charges. This gives Ben a total return after tax of \$881.00 for the year.






Actual investment mix⁶

- 1. Gross Return is the return before the deduction of tax, expenses and fees and assumes all income is reinvested.

- 4. GST is currently charged at 15% on 10% of the management fee in accordance with the non- binding IRD agreement with the Financial Services Council of New Zealand Incorporated on behalf of the funds management industry. GST on management fees is currently under review and therefore this percentage may change in the future.
- 5. Effective 1 November 2023, the Manager's basic fee (excluding GST) for the Mercer Emerging Markets Shares Fund changed from 1.35% to 1.25%.
- 6. The 'Cash and cash equivalents' sector includes cash that has been converted into equity through the use of futures contracts, providing exposure to international equities.
- 7. The Top 10 investments have been calculated excluding operational cash and derivatives.
