What is the purpose of this update?

This document tells you how the Kernel Global Infrastructure Fund has performed and what fees were charged. The document will help you to compare the fund with other funds. Description of this fund

The Kernel Global Infrastructure Fund invests in globally listed pure-play infrastructure companies and is designed to track the Dow Jones Brookfield Global Infrastructure Index (NZD).




Investors are not charged individual action fees for specific actions or decisions (for example, for withdrawing from funds). All fees are inclusive of GST.

Example of how this applies to an investor

Emma had \$10,000 in the fund on 1 January 2024 and did not make any further contributions. On 31 December 2024, Emma received a return after fund charges were deducted of \$2,508 (that is 25.08% of her initial \$10,000). This gives Emma a total return after tax of \$2,344 for the period.
