What is the purpose of this update?

This document tells you how the Sustainable Shares fund has performed and what fees were charged. The document will help you to compare the fund with other funds. Mercer (N.Z.) Limited prepared this update in accordance with the Financial Markets Conduct Act 2013.

Description of this fund

Invests almost entirely in shares. May be suitable for investors seeking exposure mostly to shares and who are comfortable with a high level of volatility in returns. This fund is managed with reference to environmental, social and governance (ESG) factors and is certified by the Responsible Investment Association of Australasia.

What are the risks of investing?

Risk indicator for the Sustainable Shares fund:



Example of how this applies to an investor


Ben had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Ben received a return after fund charges were deducted of \$977.00 (that is 9.77% of his initial \$10,000). Ben also paid \$0.00 in other charges. This gives Ben a total return after tax of \$977.00 for the year.



What does the fund invest in?


Actual investment mix

Currency hedging

Currency hedging can apply to some of the asset classes this fund invests in. The level of currency hedging for global shares is managed between 0% and 100% on a net of tax basis and may change over time depending on Mercer's view of the relative strength (or weakness) of the New Zealand dollar. Hedging coverage, on a net of tax basis, for the Fund's exposure to foreign currency as at 30 June 2025 was 50.58%.
