## WHAT IS THE PURPOSE OF THIS UPDATE?

## DESCRIPTION OF THIS FUND

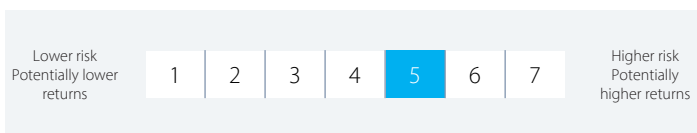
The International Share Fund invests mainly in international equities. Investments may include equities in companies that are listed or are soon to be listed on a stock exchange, and cash and cash equivalents.

The fund aims to achieve a positive yearly return (after the fund charge and before tax) that over the long-term outperforms the relevant market index.

## WHAT ARE THE RISKS OF INVESTING?

Risk indicator for the International Share Fund:



The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the fund's assets goes up and down. A higher risk generally means higher potential returns over time, but more ups and downs along the way.

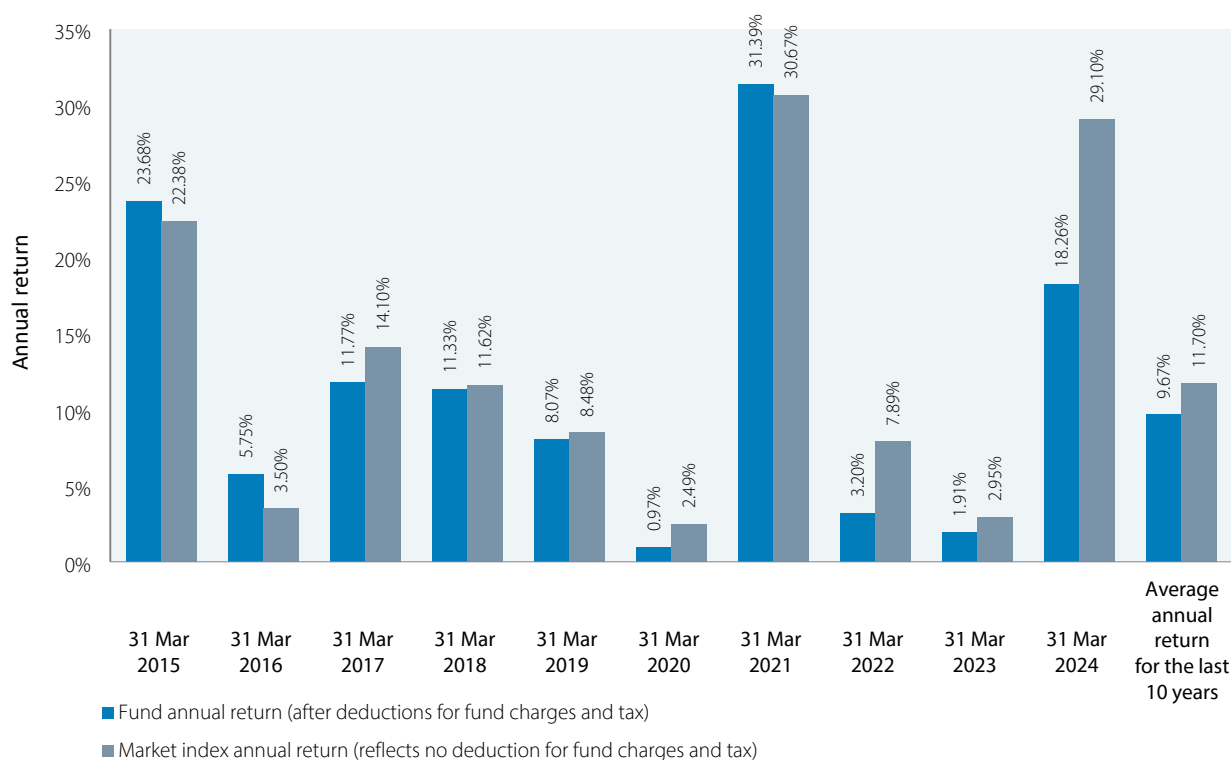

\*The manager expects that the fund charges for the next scheme year will be less than the fund charges disclosed in this fund update because the manager's basic fee was reduced to 0.91% effective 1 August 2024.

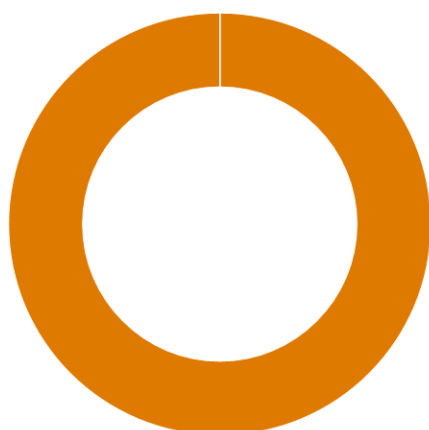
### EXAMPLE OF HOW THIS APPLIES TO AN INVESTOR

Sarah had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Sarah received a return after fund charges were deducted of \$1,237 (that is 12.37% of her initial \$10,000). Sarah did not pay any other charges. This gives Sarah a total return after tax of \$1,237 for the year.

### Actual investment mix<sup>2</sup>

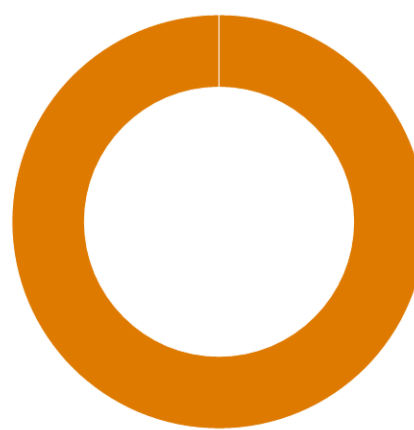
This shows the types of assets that the fund invests in.
