What is the purpose of this update?

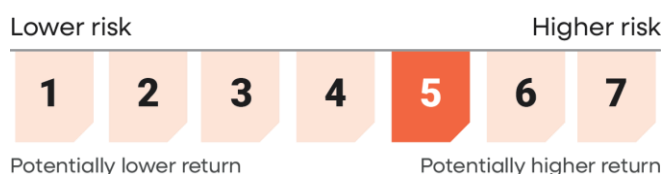
Description of this fund

The Smart US 500 ETF is designed to track the return (before tax, fees and other expenses) of the S&P 500 Index. The Index is comprised of 500 of the largest listed companies in the United States.

What are the risks of investing?

Risk indicator for the Smart US 500 ETF



The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the fund's assets goes up and down. A higher risk generally means higher potential returns over time, but more ups and downs along the way.

Note that even the lowest category does not mean a risk-free investment, and there are other risks that are not captured by this rating.

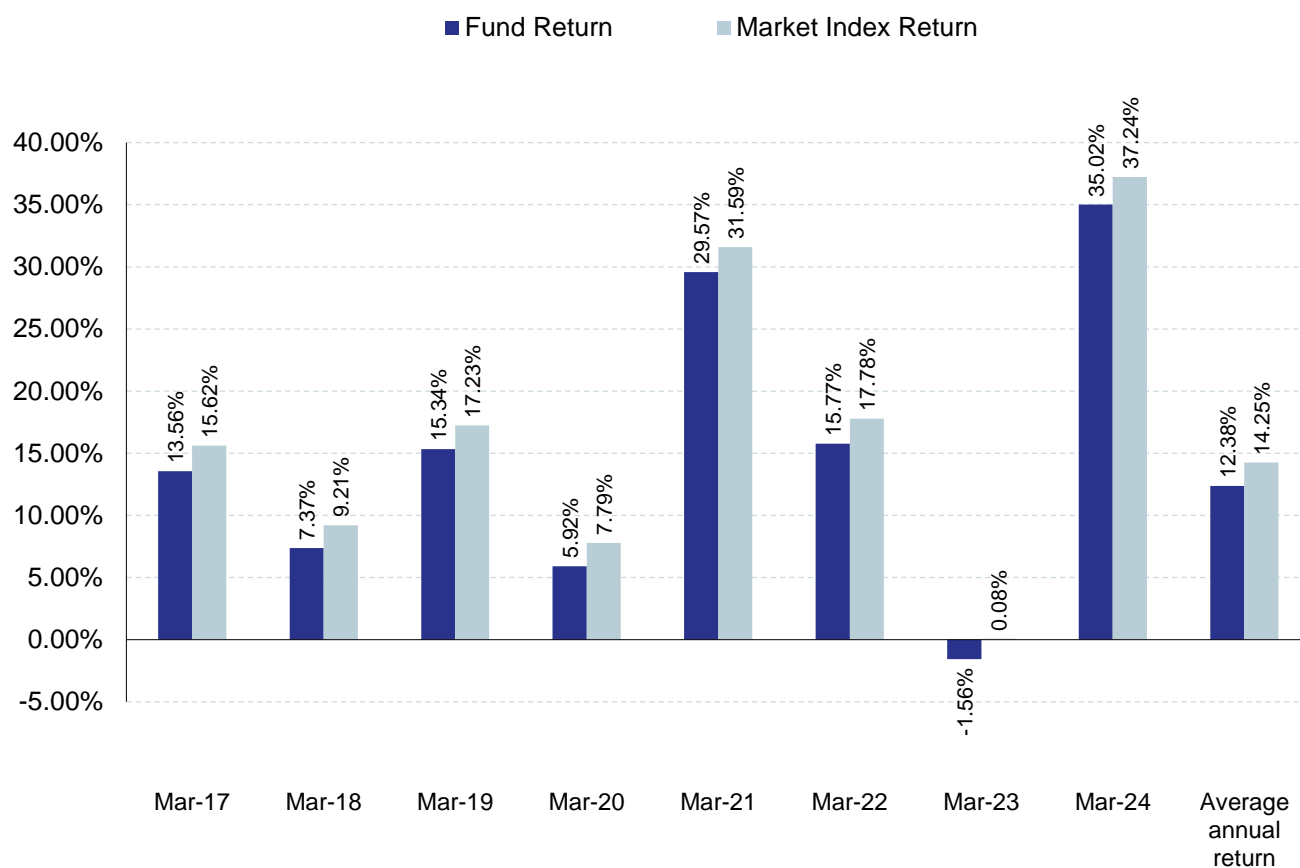

How has the fund performed?

What fees are investors charged?

Investors in the Smart US 500 ETF are charged fund charges. In the year to 31 March 2024 these were:

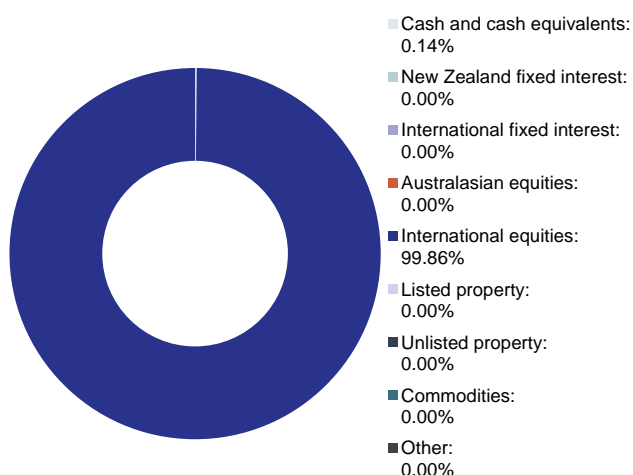
Example of how this applies to an investor

Tara had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Tara received a return after fund charges were deducted but before tax of \$2,629 (that is 26.29% of Tara's initial \$10,000). This gives Tara a total return after tax of \$2,463 for the year.
