Fund update for the quarter ending 30 June 2025

This fund update was first made publicly available on 25 July 2025.

What is the purpose of this update?

This document tells you how the Sharesies Smartshares Growth Fund has performed and what fees were charged. The document will help you to compare the fund with other funds. Sharesies Investment Management Limited prepared this update in accordance with the <u>Financial Markets Conduct Act 2013</u>. This information is not audited and may be updated.

Description of this fund

The fund invests wholly in the SuperLife Growth Fund. The fund is designed for investors that want a growth investment option that aims to achieve higher returns over the long term, with more ups and downs along the way. The fund provides exposure to a diverse range of domestic and global growth assets.

What are the risks of investing?




How has the fund performed?

Annual return graph



This shows the return after fund charges and tax for each year ending 31 March since the fund started. The last bar shows the average annual return since the fund started, up to 30 June 2025.

Small differences in fees and charges can have a big impact on your investment over the long term.

Example of how this applies to an investor

Katy had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Katy received a return after fund charges were deducted of \$1,063.04 (that is 10.63% of her initial \$10,000). Katy did not pay any other charges. This gives Katy a total return after tax of \$963.27 for the year.

Notes

- 1. A combination of actual fund returns and market index returns have been used to determine the risk indicator as the fund has not been operating for the required five years. The risk indicator may therefore provide a less reliable indicator of the fund's future volatility. Market index returns have been used until 30 April 2023 and the fund's actual returns thereafter.
- 2. The fund charges represent our best estimates of the fees and expenses that will be charged to the fund. These have been estimated using information provided by the underlying fund manager and by reference to the underlying fund's disclosure documents.
