What is the purpose of this update?

This document tells you how the Kernel S&P Global 100 Fund has performed and what fees were charged. The document will help you to compare the fund with other funds. Kernel Wealth Limited prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

Description of this fund

The Kernel S&P Global 100 Fund invests in globally listed multi-national, blue-chip companies and is designed to track the S&P Global 100 ex Controversial Weapons Index (NZD).

The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the fund's assets goes up and down. 


Investors are not charged individual action fees for specific actions or decisions (for example, for withdrawing from funds). All fees are inclusive of GST.

Example of how this applies to an investor

Emma had \$10,000 in the fund on 1 July 2024 and did not make any further contributions. On 30 June 2025, Emma received a return after fund charges were deducted of \$1,355 (that is 13.55% of her initial \$10,000). This gives Emma a total return after tax of \$1,207 for the period.
