#### Fund update for the quarter ended 31 March 2025

This fund update was first made publicly available on 1 May 2025.

### What is the purpose of this update?

This document tells you how the Smart S&P/NZX NZ Government Bond ETF has performed and what fees were charged. The document will help you to compare the fund with other funds. Smartshares Limited prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

### **Description of this fund**

The Smart S&P/NZX NZ Government Bond ETF is designed to track the return (before tax, fees and other expenses) of the S&P/NZX NZ Government Bond Total Return Index.The Index is comprised of sovereign bonds issued by the New Zealand government.

### What are the risks of investing?

Risk indicator for the Smart S&P/NZX NZ Government Bond ETF<sup>1</sup>



The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the fund's assets goes up and down. A higher risk generally means higher potential returns over time, but more ups and downs along the way.




### How has the fund performed?

### What fees are investors charged?

Investors in the Smart S&P/NZX NZ Government Bond ETF are charged fund charges. In the year to 31 March 2025 these were:

### Example of how this applies to an investor

Tara had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Tara received a return after fund charges were deducted but before tax of \$523 (that is 5.23% of Tara's initial \$10,000). This gives Tara a total return after tax of \$375 for the year.

#### **Notes**

- Market index returns (as well as actual returns) have been used to complete the risk indicator, as the fund has not been in existence for 5 years. - These charges refer to the normal fund operating costs that are charged to the fund. For disclosure purposes, supervisor, audit and legal costs are not included in the manager's basic fee, but are included in the other management and administration charges. Some of these are fixed costs so the amount shown can range from 0% up to the total fund charges depending on the total value of the fund.
