
Description of this fund

The fund aims to provide investors with capital growth over the long-term, by investing primarily in a broad spread of Australasian and international equities, with a small amount held in cash.

What are the risks of investing?

Risk indicator for the SBS Wealth High Growth Fund:



Example of how this applies to an investor


Hayley had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Hayley received a return after fund charges were deducted of \$589 (that is 5.89% of her initial \$10,000). This gives Hayley a total return after tax of \$487.00 for the year.

Currency hedging

As at 31 March 2025 the fund has an exposure to foreign currency assets of 83.92%, of which 36.21% was hedged back to NZD. This means the fund's foreign currency exposure is 47.71%.
